#### SET UP YOUR REGISTRATION PAGE



Time to set up a registration page so those interested in your webinar can register! Check out our webinar registration page language and imagery suggestions <a href="here">here</a> and use them to gather registrant information on your platform of choice!

We recommend building your page 4-6 weeks out to allow for ample time to promote your event!

#### REGISTRATION CONFIRMATION & REMINDER EMAILS



Set up your registration confirmation email, which will go out to those who registered for your event. This email will include instructions on how to access the webinar. You'll also want to send out reminder emails leading up to the event so your registrants don't forget! Download the template for both email types, <a href="here">here</a>.

Please note, if you use a webinar or event platform such as Go-to-Webinar or Zoom, these features may be built-in!

#### PROMOTE YOUR WEBINAR



Now, it's time to drive some attendance! Access our social media ads <u>here</u> and our email invitation templates <u>here</u> to start spreading the word about your upcoming webinar!

Post multiple times a week on social media and send 1 email/week to your audience! Take it up a notch and GO LIVE to promote your event!

### REVIEW WEBINAR TALKING POINTS & SLIDE DECK

## GIVE A KILLER PRESENTATION
